

## **General Information Replacing an OLD NATIONAL IDENTITY CARD:**

- Applicants must **FIRST** Complete the Family Social ID Forms
- Old National Identity Card Must be at hand during and after to receive his/her new ID
- Father's Given Name (Father Name, Grand Fathers Name and Great Grand Father Name)
- MOTHER's GIVEN NAME(Father Name and Grand Father Name)
- Father's and Mother's Place Of Origin; Date and Place Of Birth
- Religion
- Parent's Eritrean ID No

### **Photograph Requirements Include The Following**

- **Four (4) Colored Pictures ( 35X45 mm or 1.4x1.8 inch)**
- **Full Face view directly facing the camera (both ears must show, do not smile or open mouth; Background must be whit)**
- **Full Name Must Be Written on the backside**
- **Eyeglasses Should Worn if Prescribed by a doctor**
- **No Sunglasses or Hats (Head garbs worn for religious purposes are allowed)**
- **National ServiceⓂA) Reference Number (B) Batch Number**
- **Height (height in meter)† Weight in (Kilogram) †**
- **Blood Type: A, B, AB or O**

### **Additional Information Applying for a SOCIAL ID:**

- **National Identity Card Number and Name (as it appears on the ID)**
- **Passport Number and Name (as it appears on your passport)**
- **Ethnic Group: Tigrigna, Tigre, Bilen, Kunama, Saho, Afar, Nara, Rashaida, Hadareb**
- **Personal Background (Education Level Property, Field of Experience, Phone# and E-mail)**
- **Copy of Green Card Or Passport or Copy of Birth Certificate**
